### Minutes

1. Approval of the Agenda

The agenda was approved unanimously.

2. President's report

Ahlan Marriott presented the report (Appendix A), Mutations, membership fees, Conference Warsaw and Ada Switzerland's involvement, mostly GE people at tutorials, Conference in Spain may be uncertain.

3. Treasurer's report

Marcel Schneider presented the Account 2019. The report is summarized in Appendix 2. The question arose: Does Ada-Europe Membership fee cover the AUJ and Swiss postage?

Answer: Ada-Europe Membership fee is 50 CHF. For the AUJ 35 EUR (37 CHF) are paid to Ada-Europe and postage costs 10 CHF. Total costs are 47CHF. They are covered.

4. Report of the independent auditor

Peter Vogelsanger presented the report. The indepdendent auditor's report was approved unanimously.

5. Motion 1: to approve the 2019 result as presented by the Treasurer

The motion was moved by Ahlan Marriott and the Treasurer's Report was unanimously approved.

6. Approval of the re-election of the existing board members

It was unanimously agreed that no change was wanted.

7. Election of the independent Auditor for 2020

Peter Vogelsanger volunteered again to audit the 2020 accounts.

8. Ada Europe conference 2021 – request for industrial presentations from Ada Switzerland members

For non-academic presentations a comparison to Fosdem was made. President Ahlan Marriott encourages everyone to actively participate.

9. Should there be an Ada Switzerland event in 2020? Suggestions and ideas are invited, and members appointed to organize a chosen event.



A "mini" event was suggested, possibly next year at Sternwarte Schaffhausen - an evening at the observatory and planetarium. It would take place towards the end of the year (2021), organised by Urs Maurer if he agrees to it. Small presentations possible, perhaps one by Urs.

10. A "Swiss Ada Event 2020" would require some funding be provided by Ada Switzerland.

It was agreed that a possible Ada Switzerland event would probably require funding from Ada Switzerland reserves if no sponsor steps forward.

Motion 2: to approve the funding of this event.

The Motion was carried unanimously.

#### Mutations:

- Jacek Prorok stopped being an indirect member of Ada-Europe but has remained a member of Ada-Switzerland
- We gained two new members since our last GA
  - 1. Paolo Ammann
  - 2. Milán Redele

As a consequence, our membership for 2020 has grown to 31 members, 26 of whom are also indirect members of Ada-Europe.

### Ada-Europe

- Membership figures have stabilised at around 200.
- The financial position of Ada-Europe is currently very healthy mainly due to sponsorship from small companies.
- This year's Ada-Europe conference was scheduled to be held between the 8<sup>th</sup> and 12<sup>th</sup> of June in Santander, Spain.
- The 2021 conference was planned to take place in Ghent, Belgium.
- I expected to attend a meeting on 21-Mar-20 in which the program of the Santander conference was to be decided.

However, the Covid-19 virus has changed all that. My meeting has been cancelled and will be replaced by a tele-conference. The first item on the Agenda will be to discuss whether or not the Santander conference should go ahead as planned or be postponed or cancelled.
